Timeline of Projects

The Bjornson Environmental & Recreational Center is a 443 acre school forest located in the Knapp hills. In addition to serving as an educational site for school programming, the site is also a functioning tree farm with an active forest management plan. Below is a recent timeline of major projects that have occurred and/or are planned at the site. In a typical year, the site is visited by K-12 classrooms, most frequently in the fall and/or spring, as well as by various community groups.

**School Year 2015-2016**

- Environmental Site Coordinator Vacancy - Position remained unfilled for school year

**School Year 2016-2017**

- Environmental Site Coordinator position filled by combining with District Innovation Specialist Position - Both positions vacated late summer 2017
- Completion of most recent timber sale harvest completed
- Update to main entrance road
- Meet with representatives of
- Dunn County Energy solar garden project approved

**School Year 2017-2018**

- Environmental Site Coordinator position filled by combining with Knapp/Downsville PE Position
- Dunn County Energy solar garden installed
- Timber sale planning - Select cutting/thinning of pine plantation

**School Year 2018-2019**

- Begin Review of Forest Management Plan with DNR
- Marking of trees for select cutting/thinning of pine plantation (Collaboration with DNR/Agriscience & Environmental Biology Classes - High School)
- Development of [environmental site goals](#) and associated action plan

**Summer 2019**

- Camping cabin maintenance begins - Installation of steel roofs, staining, and general maintenance
- Construction of "Tiny Home" accessible camping cabin - Eagle Scout Project
- Review of existing Environmental Education curriculum scope and sequence

**School Year 2019-2020**

- Begin update to K-5 Environmental Education curriculum
- Bidding process for timber harvest postponed due to mill shutdowns due to COVID-19 pandemic
- Timber harvest - (Select cutting/thinning of pine plantation) postponed due to COVID-19 pandemic

**School Year 2020-2021**

- Suspend classroom visits to SDMA Environmental Site due to COVID-19 mitigation protocols
- K-5 Environmental Education Team restarts work on updates to K-5 environmental education curriculum that was paused due to COVID-19 pandemic
- Meet with DNR Forester to review plans for updating timber harvest plans - Select cutting/thinning of pine plantation
- Meet with DNR Forester to investigate additional timber sale select/clear cut of an identified area for a deer enclosure on the site

- Pilot updated K-5 Environmental Education curriculum
- Develop maintenance work plan for summer 2022
